

2013 MAOTeen Local Guide for Preparing 2013 MAOTeen Local Contestant Contract

(Effective September 30, 2012)

The information below has been prepared to assist you with completing the "Application and Contract for Competing in the 2013 State and Local Pageants of the Miss America's Outstanding Teen Competition" by explaining the purpose of most of the blank spaces. This guide is specific to competing on the local teen level. A separate guide is available for teen contestants who are competing on the state level. Every contestant in a Miss America's Outstanding Teen Local Pageant is required to complete this application and contract, as well as have the applicable signatures and initials from the contestant and contestant's parent(s) or legal guardians. The contract must also be notarized in the applicable places. You will not be able to save the "Application and Contract for Competing in the 2013 State and Local Pageants of the Miss America's Outstanding Teen Competition" form with any of the data you have entered in any of the blank spaces, so be prepared to print the contract once you have finished entering the information based upon the guidelines below. If you print the document and then discover you have missed a blank space or two, just manually write in the missing information using a pen.
